CAREER BRIEF

Dr. Mears is a Distinguished Research Professor and the Mark C. Stafford Professor of Criminology in Florida State University's College of Criminology and Criminal Justice, a Fellow of the American Society of Criminology, and recipient of the Bruce Smith, Sr. Award, the Academy of Criminal Justice Sciences' most prestigious honor, for outstanding contributions to knowledge in criminal justice. He conducts research on crime, justice, and policy. As a Principal Investigator or Co-PI on over \$5 million in external funding, and as lead researcher, he has conducted studies supported by the National Council on Disability, National Institute of Justice, National Institute on Drug Abuse, and the Office of Juvenile Justice and Delinquency Prevention, state agencies, and the California Endowment, Hogg Foundation for Mental Health, Joyce Foundation, and William and Flora Hewlett Foundation. In addition to receiving teaching, mentoring, and service awards, he has been ranked as a top lead or sole-author publisher in criminology¹ and a top-10 most influential criminologist.² Citations = 14,480; H-index = 70.

He is the author of Out-of-Control Criminal Justice (Cambridge University Press) and American Criminal Justice Policy (Cambridge University Press), both awarded the Academy of Criminal Justice Sciences Book Award; Prisoner Reentry in the Era of Mass Incarceration (Sage); Fundamentals of Criminological and Criminal Justice Inquiry (Cambridge University Press); The Reinvention of Policing (Rowman & Littlefield), awarded the Academy's Police Section's Best Policing Book of the Year Award; The Oxford Handbook of Evidence-Based Crime and Justice Policy (Oxford University Press); and Comprehensive Deterrence Theory (Cambridge University Press). His work has appeared in such journals as Criminology, Journal of Experimental Criminology, Journal of Research in Crime and Delinquency, Justice Quarterly, Law and Policy, and Sociological Perspectives. Media coverage of his work has appeared in ABC News, Austin American-Statesman, Baltimore Sun, Boston Globe, CBS News, Dallas Morning News, Fox News, The Guardian, The Hill, The Houston Chronicle, International Herald Tribune, Los Angeles Times, Miami Herald, New York Times, Orlando Sentinel, Time, United Press International, USA Today, and Washington Post, among others, and in television and radio news shows.

Dr. Mears is nationally and internationally recognized for advancing a systems approach to understanding and improving public safety and justice and, more broadly, to advancing theory and research on solitary confinement and restrictive housing, sentencing, mass incarceration, juvenile justice, policing, crime prevention, and policy. He is an expert on mixed-methods studies, including use of experimental and quasi-experimental designs as well as collection and analysis of quantitative and qualitative data. (Fewer than 10% of empirical articles in criminology journals employ experimental or qualitative data.³) He previously served as a Senior Research Associate at the Urban Institute, held a Post-Doctoral Research Fellowship at the University of Texas at Austin, taught at American University's School of Public Affairs and at Southwestern University, and was an Evaluation Research Fellow with the Hogg Foundation for Mental Health. He also served as a Peace Corps Volunteer in Micronesia and as a program manager and counselor working with abused and juvenile justice-involved youth.
