Course Description

This course is designed to provide students with an understanding of the history, trends, research, and theories of the United States' court system. Specifically, the course will focus on (1) the roles, responsibilities, and challenges faced by key personnel functioning daily within the courtroom, (2) court organization, (3) courtroom proceedings, (4) court rulings, and (5) criminal law concepts. By the end of this course, students will be able to demonstrate a thorough understanding of the history, structure, status, and issues in United States courts.

Course Objectives

- Understand the basic functions of the court systems within the United States
- Differentiate between and understand the roles of key court system personnel
- Understand the Constitutional procedures governing arrest and trial
- Understand court organizational structures
- Explain how trial courts operate and differ from one another
- Describe the role of appellate courts and the importance of various review standards
- Understand general court procedures
- Understand the significance and meaning of court rulings
- Understand the sources of law
- Evaluate statutes and apply their elements to specific cases
- Identify the similarities and differences between criminal offenses
- Assess the challenges in court processes and investigate possible solutions

Exams

There will be four exams (for dates see below). The exams will be administered in person, in class. Exams will be multiple choice. The Midterm and Final Exam will be comprehensive (contain information that we have covered up to that point in the semester). Meanwhile, Exams 1 and 3 will only cover information over those units. If a student is unable to complete an exam on the scheduled date, they should contact the professor **at least** 24 hours in advance. Students who miss an exam without a formal excuse will receive a 0. The exams will be administered in the normal classroom on the following day/times:

Quizzes

Every other week(end) there will be a quiz available on CANVAS. The quizzes will consist of both multiple choice and short answer questions based on the topics covered over that 2-week period. The purpose of these quizzes is two-fold: (1) engage you all in the material outside of the classroom setting and (2) help prepare you for the exams. Quizzes will be due by Tuesday at 3:05pm EST (the start of class) of the following week. Quizzes not turned in on time will receive a 0 and there will be no opportunity to make up missed quizzes. Use of artificial intelligence, such as ChatGPT, for the quizzes is prohibited and will result in a 0 for all questions—not just the question you used it for.

Case Study

The case study requires the student to research a statute, as well as an accompanying case brought under that statute. The goal is to show an outline of each element of a law and demonstrate how the prosecution succeeded in proving, or failed to prove, each of these elements in a specific case. The case must be disposed of via trial—no pleas. There are two ways this assignment can be completed. First, the student can turn in an infographic. I will provide more

detailed information on the instructions of the infographic, but part of the infographic grade will be clarity of the material—so be consistent with factors such as titles, headers, spacing, citations, and fonts (sizes and styles). When uploading the infographic, it must be a PDF. Second, the student can write a one-to-two paged, single spaced, paper. If this option is taken, the submission must be a Word document (**no** .pages or google doc files), Times New Roman, 12-point font, and 1-inch margins.

You must use APA citations for the statute you are drawing upon and the case you are describing. The use of artificial intelligence, such as Chat GPT, is strictly prohibited and will result in a 0. The case study will be due on November 13th, 2025 at 11:59pm EST.

Extra Credit

There will be one opportunity for extra credit – available to all students. No extra credit opportunity will be specific to a student, please do not ask.
