CAREER SUMMARY

George B. Pesta is an Associate Professor in the College of Criminology and Criminal Justice and Director of the Center for Criminology and Public Policy Research at Florida State University (FSU). He has worked in the field of criminal and juvenile justice research and policy since 1997. Since 2013, he has facilitated the growth of the Center by working collaboratively with college faculty and agency partners. He has managed millions of dollars in external research funding and developed and sustained research and policy partnerships with several state and local organizations.

In addition to higher education administration, Dr. Pesta has taught and worked with individual students through research assignments and individual study courses. He has actively been engaged in collaborative research, particularly in juvenile justice and corrections, including conducting interviews and focus groups, survey development and administration, and data collection. His research has resulted in 35 co-authored articles and chapters, 50 research reports, and over 100 presentations at professional academic, policy, and practitioner meetings.

He has spent his career employing research to help inform policy and practice. As Director of Education Planning and Development for G4S Youth Services, he developed policies focused on evidence-informed transition and reentry services, education services, and evaluation for delinquent youth in residential facilities.

For 12 years, Dr. Pesta worked on the Juvenile Justice Educational Enhancement Program as a research faculty member in the College of Criminology and Criminal Justice. He conducted program evaluations and performance monitoring of juvenile justice education programs. He also conducted research in the areas of delinquency, education, and reentry. Notably, he worked to implement research evidence into policies and practices across the U.S. that could improve conditions for residential youth and increase their likelihood of desistance from further delinquency.
