#### COURSE DESCRIPTION

This course introduces students to the intersection between criminal activity, morality, and law through the social lens of deviance. Through traditional lectures and weekly discussions of topical readings, students will be exposed to an interactive learning environment. Students will have the opportunity to learn about a variety of topics such as, theories of deviance, homicide, drug use, domestic violence, cyber deviance, mental illness, and white-collar crime. The aim will be to help students understand the social impact of these crimes and why social reactions to these events matter.

#### ATTENDANCE POLICY

Students MUST attend discussion-based and exam days. For students who cannot come inperson to a discussion day due to illness, a live virtual option will be given.

#### **DISCUSSION PARTICIPATION**

To create a more interactive learning experience, students will be asked to do a weekly reading assignment and come prepared each week to discuss that reading. Students are expected to significantly contribute to the discussion at least twice during the class-period. This assignment is worth 10 points per discussion (20% of overall grade).

#### DISCUSSION LEADER

To encourage active participation in the learning process, students will be asked to be a discussion leader once during the semester. Discussion leaders are expected to come prepared with talking points and/or questions for the class, as well as provide a one-page (single spaced) summary of the week's assigned reading. This assignment is worth 100 points (20% of overall grade).

#### **PAPER**

To enhance learning and absorption of class material, students must complete ONE writing assignment (worth 100 points, 20% of overall grade). The paper must be 6-8 pages in length (excluding title and reference pages), use 12-point Times New Roman font, be double spaced, use 1-inch margins, and be submitted through Canvas as a Microsoft Word document (.doc, .docx). Brief directions and prompts are below:

Deviance is Everywhere:

- For this paper I want you to do the following:
  - o Find and get approved a true-life documentary that involves deviant persons or behaviors and watch it.
  - Section 1: Explain how deviance is defined in the film and by whom. Does everyone share the same definition of deviance? Does anyone consider the persons or behaviors criminal? (20 points)
    - Use class material on defining deviance to help with your answer
  - Section 2: Relate the events of this documentary to **two** of the topic areas we discuss in class (please ask for approval if you are not certain) (30 points)
    - For each area explain how scenes from the film are reflective of what was learned in class
    - Do the scenes from the film reflect what we see in the research about this topic? If so, how? If not, why do you think that is?
  - Section 3: Discuss the policy implications that do or could occur from the types of deviance shown in the film? (30 points)
    - Are there legal, moral, or social penalties?
    - Do people of this group find themselves in more trouble with the police? Or are they able to avoid detection?
    - What are the individual and societal harms that come from the behavior? What harm is done if behavior is not stopped?
  - Section 4: In your view how do you think this form of deviance should be dealt with? Do those who engage in it need to change or do those around the person need to change their definition of deviant? (10 points)
    - What about criminal/legal consequences?
  - O You must use empirical research findings to support the idea that this theory can help explain the racial divide and to support your personal views. You must have a minimum of FOUR peer-reviewed sources. (5 points)
  - o Proper spelling, grammar, and APA formatting will also be assessed. (5 points)

#### **EXTRA CREDIT**

There is NO extra credit for this course.

#### **EXAMS**

To assess basic knowledge of course material students will be given two exams (one midterm, one final) during the semester. These exams will be comprised of 50 multiple choice questions (worth 2 points each) and will be worth 100 points each (40% of overall grade).

- Exam Day Protocol: On the day of the exam students must bring a pencil and FSU ID card (students without a proper ID will not be allowed to turn in their exam and will receive a zero). Headphones, smart watches, phones, and any other electronic device are not permissible during the exam.
  - \*In rare occasions where students must take exam virtually, they will be administered via Canvas and Honorlock. These students are responsible for making sure their devices meet the qualifications for Honorlock.
- *Make-up Policy:* Students MUST contact the instructor at least 48 hours in advance if they cannot make the scheduled midterm or final exams. Make-up exams will be an all-written format and must be complete within one week of the originally scheduled exam. \*Note: it is the responsibility of the student to contact and ensure the completion of the make-up exam.
