Course Description

This course introduces undergraduate students to the basic concepts involved in evaluating and conducting research within the field of criminology and criminal justice. This will begin with learning the general components and purpose of social science research. Students will then engage with each component via academic journal articles to understand different types of research methods, including: experiments, surveys, secondary data analysis, and interviews. The course will conclude with an introduction to basic statistics often utilized in describing and presenting criminological research.

This is an in-person course (not an online or hybrid/FLEX course). Students are expected to attend lectures and take exams in person.

Course Objectives

Over the course of the semester, students will learn how to demonstrate application of research and analytical skills, including:

- Critically evaluating criminal justice research published in the field
- Generating testable hypotheses
- Defining and operationalizing key constructs
- Selecting the most appropriate study design or method
- Interpreting statistical results in real-world terms

Required Readings

Bachman and Schutt. 2021. *Fundamentals of Research in Criminology and Criminal Justice*, 5th edition. Thousand Oaks, CA: Sage. Please do not purchase older editions of this textbook, as they are substantially different. You are required to obtain the textbook within two weeks of the beginning of class.

Additional readings will be posted on Canvas.

Course Grading

Student progress will be evaluated with two in-class exams, a cumulative final exam, reading check quizzes, and two short take-home assignments. All students are also required to complete an ungraded pre- and post-test designed by the University on Canvas.

Midterm and Final Exams

Exams will include multiple-multiple choice questions (e.g. select all that apply) as well as short answer responses. The final exam is cumulative, but will focus most heavily on the final third of the material, which is not covered on either midterm exam. When applicable, specific grading rubrics will be provided.

Assignments

Students will be required to complete two short writing assignments of 3-5 double-spaced pages. Plagiarism is strictly prohibited, and all references or sources must be properly cited. Grading rubrics will be provided with the assignments. Assignments must be submitted via Canvas at the start of class on the day they are due (not at 11:59 pm!).

Reading Check Quizzes

Students must complete a brief quiz on the material before the start of each chapter (specific dates are listed in the tentative calendar below). These quizzes are designed to help students practice the material and prepare for the exams, and so working together with other students or asking for help is encouraged (copying assignments is not allowed, however). Reading check quizzes are open book/open note, and students are encouraged to double check the material to ensure they know the correct answers. There is no time limit on reading check quizzes and students may attempt the quiz as many times as desired. Reading check quizzes must be submitted at the start of class on the day they are due (not at 11:59 pm!).

Grading Policies

Absolutely no extra credit will be given or accepted under any circumstances. Exam grades will only be curved if the student average falls below a B-, and will be curved to this level accordingly. Final grades will not be rounded.

Major Requirement

The College of Criminology and Criminal Justice requires all students to receive a grade of C or higher in this course (CCJ 4700) in order to continue in the major. Students with a grade of C- or lower will be required to retake this course to satisfy the major requirement.

Course Policies

Attendance, Missed Work, and Make-up Exams

Due to the global COVID-19 pandemic, attendance is not graded and students will not be directly penalized for missing class. However, in-class lectures feature content that is not covered in the textbook that will be included on the exams, so students are highly encouraged to attend class. All lectures except exam review sessions will be recorded.

Missing Exams: Students will be permitted to make up exams only when he or she: (1) has an officially recognized absence; and (2) provides official documentation of the absence. Excused absences include documented illness, deaths in the family and other documented crises, call to active military duty or jury duty, religious holy days, and official University activities. If the exam is missed due to a prescheduled issue (e.g., athletic game, religious observance), the student must contact me at least one week prior to the exam. If the exam is missed due to unforeseen circumstances (e.g., sudden illness or family emergency), the student must contact me within 24 hours of the missed exam. Time and format of the make-up exam will be decided at my discretion. Please be aware that make-up exams will contain different questions that may or may not be more challenging than the original exam given in class. Students that do not adhere to these guidelines will receive a zero for the missed exam, without exception.

Missing Lectures: Students are not required to report an absence for regular lectures. However, students must contact Kristen Neville at <u>kjn14b@my.fsu.edu</u> to request access to lecture recordings. Lecture recordings will only be distributed to students who provide documentation of an excused absence. In cases when a student expects to miss class for an extended period of time or multiple classes regarding the same issue, he or she must contact me as soon as possible. All circumstances will be evaluated on an individual basis. Students are responsible for all announcements as well as making up all missed work and exams.

Late Assignments: Late submissions for assignments and reading check quizzes (not due to an excused absence) will be accepted up to three days after the due date, with a penalty of 10% per day. No submissions will be accepted more than three days past the due date without an excused absence. Students with an excused absence will not be penalized for late submissions, but must coordinate a new due date with me.

Accident Forgiveness

In some cases, students struggle in the beginning of the course, yet demonstrate mastery of the content by the end of the semester. To recognize this hard work, students are permitted to replace one of their two exam grades with their final exam grade. Stipulations:

- 1. Students must take all three exams.
- 2. Only the final exam can be used to replace another exam grade (Exam 2 cannot be used to replace Exam 1, etc.)
- 3. The final exam grade can only replace one exam, not both. Assignment and reading check quiz grades cannot be replaced with the final exam grade.
- 4. This policy will be applied automatically at the end of the semester to the lower of the two exams. If the final exam grade is lower than both exams, no scores will be replaced.
