Course Objective:

This course is designed to give you a better understanding of law enforcement, concentrating predominantly on the police. Specifically, we will examine the functions and responsibilities of law enforcement (i.e. public service, maintaining safety and order, sustaining community relations). By the end of this course you should have a general understanding of each of these topics and can explain their trends, history, and impact on the criminal justice system.

Exams & Grades:

The course is primarily made up of 3 exams. The dates are as follows:

Exam 1: September 22nd

Exam 2: October 12th

Exam 3: December 7th – “FINAL EXAM”

*The Final Exam is NOT cumulative.

*Final Exam must be taken on this date as specified by the University

Exams may take the following formats: true/false, multiple choice, short answer or essay. Each exam must be taken as there is **NO dropping of your lowest exam grades**. Each exam must also be taken at its scheduled time. Exceptions will only be made for students with documented excuses. Please see the University Attendance Policy for procedures of missed exams. **Each exam is worth 100 points, for a total of 300 points** (there are 3 exams).

Final grades will be computed by dividing your point total by 300 (the total number of grades you are being held accountable for) to produce an average. The following cut-off will be used to determine grades:

Extra Credit:

Prior to each exam, there will be **one class day devoted to a review session**. This review is crucial to performing well on the exam. If you do not attend the review, you will not get the review materials (see University Attendance Policy for more information). During the review, you will have the opportunity to take notes, ask questions, and take home a ‘fill-in’ sheet (more details to come closer to exam 1). If you bring this sheet (your notes, note cards, etc.) to the exam, you will receive **2 extra credit points towards your exam**. This is to not only reward students who study, but also to encourage students to participate in the review.

There will be three guest speakers throughout the semester. Students will receive **2 extra credit points towards an exam** if they 1) attend class and 2) bring in three questions to ask the guest speaker.

Therefore, there will be a **total of 12 extra credit points** offered throughout the semester. These points come from the three review sessions & the guest speakers and go towards that exam only (i.e. review session for exam 1 will only go towards exam 1).

No alternative opportunities for extra credit will be given.

Make-up Policies:

Exams and assignments may be made up provided the student has a university approved excuse. **Such excuses include:** illness, deaths in the family or other crisis, call to active military duty or jury duty, religious holy days, and official University activities. All excuses must include **proper documentation** within **one week** of the missed exam/assignment. This is in accordance to University policy and is up to the discretion of the instructor.

Classroom Policies:

Class attendance is necessary in order to do well in this course. The exams are designed to test your knowledge of in class assignments, lectures, and course readings. If you miss a class, it is your responsibility to obtain missed materials. I encourage each student who misses a class to contact another student for missed notes as notes will not be given by the instructor. Class will consist of lectures, class discussions, relevant movies/documentaries, guest speakers, and in class assignments. Students are encouraged to participate in class.

Students are responsible for regularly checking their FSU emails and Canvas as reading assignments may change.

University Attendance Policy:

Excused absences include documented illness, deaths in the family and other documented crises, call to active military duty or jury duty, religious holy days, and official University activities. These absences will be accommodated in a way that does not arbitrarily penalize students who have a valid excuse.
