Developmental trajectories of low impulse control coupled with high sensation seeking are associated with greater adolescent delinquency. In addition, several studies link adverse childhood experiences (ACEs) to lower self-control and increases in delinquency. In this study, we use latent class trajectory analysis to develop and test an integrated model which synthesizes these two strands of research. Carter Hay was a professor at the FSU College of Criminology and Criminal Justice. Poco Kernsmith was a professor at Wayne State University.
